Mutual Benefit between MHCAPB and NBFE

National Board of Forensic Evaluators, Inc, hereinafter referred to as "NBFE," and Mental Health Counselors Association of Palm Beach hereinafter referred to as "MHCAPB"

The parties agree as follows:

Whereas, MHCAPB wishes to enter into an agreement with NBFE for their mutual benefit, and whereas NBFE agrees as follows:

NBFE shall provide the following:

- 15% discounted rate (currently \$500) for the full certification fee for the CFMHE credential available to all members of MHCAPB. This fee includes the application fee, written examination fee, oral examination fee, review and critique of sample forensic report, 8-hour certification workshop, and access to the "Members Only" portion of www.nbfe.net, which contains additional written training materials and videos as well as access to NBFE's forum, where applicants can ask forensic evaluators questions at no cost.
- 2. A Link from the NBFE website to the MHCAPB website
- 3. Official NBFE endorsement of MHCAPB, as well as recommendation that all CFMHEs who are licensed counselors in the Palm Beach County region of Florida join MHCAPB
- 4. Free access to quality, quarterly NBFE webinars on a range of topics relevant to forensic mental health evaluation (attendees may register and attend for free, or they may elect an optional administrative fee to receive a CEU certificate currently set at a rate of \$5 per continuing education hour for live events and \$10 per continuing education hour for "on demand" trainings and homestudies)
- 5. Consultation and technical expertise to the board of MHCAPB on professional advocacy matters related to forensic mental health evaluation

MHCAPB shall provide the following:

- 1. Display of the NBFE logo with a link to the NBFE website on MHCAPB's website
- 2. MHCAPB endorsement, recognition and recommendation of NBFE and the CFMHE credential for its clinicians
- 3. NBFE materials made available at MHCAPB training events if requested by NBFE

If MHCAPB would like NBFE to provide a live certification workshop webinar accessible to MHCAPB members who have paid their certification fee:

- 1. NBFE will pay MHCAPB 20% of the tuition for each attendee (at the current rate, this would amount to \$100 per clinician and \$50 per student/intern)
- 2. MHCAPB will promote the training to its membership

If MHCAPB would like NBFE to provide a live certification workshop in-person in Palm Beach County, Florida accessible to MHCAPB members who have paid their certification fee:

- 1. NBFE will pay MHCAPB 20% of the tuition for each attendee (at the current rate, this would amount to \$100 per clinician and \$50 per student/intern)
- 2. MHCAPB will promote the training to its membership
- 3. In the event that MHCAPB is unable to secure at least 10 attendees for the workshop, MHCAPB will be asked to reimburse NBFE the following expenses: fuel reimbursement for trainers' travel to the training, 2 nights hotel stay for trainer, \$50 for meals on trainer.
